Based on Article 46 (2.3) in connection with Article 3 and 4 (2), according to the Law on the Organization and Competences of Government Authorities in War Crimes Proceedings, I am raising the following

INDICTMENT

Against:

ON THE CHARGES SET FORTH BELOW:

Violating the rules of international law of the IV Geneva Convention Relative to the Protection of Civilian Persons in Time of War of 12 August 1949 – Article 3 (1), in connection with Article 13 (2) and Article 4 (2.a) of the II Additional Protocol to the Convention on the Protection of Victims of Non-International (Internal) Armed Conflicts, in the second half of 1991 during the internal armed conflict in the SFRY, then an internationally recognized state, between the JNA army and other armed formations within the then SAO Krajina on the one hand, and on the other, organized armed units of the National Guard (ZNG) and the Croatian Police forces, then one of the federal units of the SFRY, on the night between 22 and 23 December 1991, in the municipality of Slunj in the Republic of Croatia, by prior agreement, together with AV, against whom the final judgment of the County Court in Karlovac K.no.2/01 dated 16 November 2001 was completed and who is currently serving his sentence; both suspects together were members

of the armed units within the authorities of the then SAO Krajina, and carried out an attack on certain civilians who did not participate directly in the conflict, thus causing the death of one person; they arrived to the Health Center in Slunj in a black Mercedes, demanding that AV, nationality..., set out with them to Cetingrad, to allegedly provide medical assistance to a large number of wounded persons, which was untrue; the mentioned person, acting on their request and carrying a doctor's bag, set forth with them in the mentioned car, heading out of town towards the town of Mali Vuković, only to stop in the parking lot in front of the Suzi inn, and when the appellant got out of the car and headed towards the entrance of the said facility, several projectiles were fired at him from a distance of only a few meters; namely AA from an automatic rifle, and AV from a 7.62 mm caliber pistol, inflicting multiple gunshot wounds, of which the afore mentioned died on the spot,

By which he committed the crime of war crime against civilians under Article 142 (1) of the FRY Criminal Act, acting as a co-perpetrator, recognized by Article 22 of the FRY Criminal Act.
