Pursuant to the provisions of Article 47 (1) of the Law on International Legal Assistance in Criminal Matters, we are regulating, according to the laws of the Republic of Serbia, the confirmed indictment of the Prosecutor's Office of Bosnia and Herzegovina number T20 0 KTRZ 0013404 17 of 10 January 2018 against the accused AA, under Article 43 (2. 5), Article 331 (1, 2) and Article 332 of the CPC and Articles 3 and 4 (1) of the Law on the Organization and Competences of the Government Authorities in War Crimes Proceedings and thus, I am raising an

INDICTMENT

Against the following:

1. **A.A.**, father's name and mother's name, born in....., born on, municipality of, UPIN, residing in, citizen of....., literate, with a school diploma of, by occupation,, with no criminal record, released pending trial,

as there is reasonable doubt that he had carried out the following:

During the non-international armed conflict in Bosnia and Herzegovina between the Army of Republika Srpska and the police of Republika Srpska on the one hand and the Army of Bosnia and Herzegovina on the other, as a member of the Republika Srpska police force, and violating the rules of the IV Geneva Convention Relative to the Protection of Civilians in Time of War of 12 August 1949, and especially Article 3 of the Convention, on the territory of the municipality of Višegrad, together with several other persons, he had performed other illegal confinements of civilians based on ethnic discrimination,

By carrying out the following:

On 16 June 1992, during the afternoon hours, uniformed and armed and together with several other members of the Republika Srpska military and police forces, he had participated in the illegal deprivation of liberty of Bosniak civilians, namely BB, VV, DD, DjDj and EE. The group had arrived in red Lada Caravan and blue Zastava 750 – ‘Fića’ passenger vehicles to the Dobrun settlement, Višegrad municipality, on the left bank of the Rzav River, whereupon they deprived the civilians BB, VV and DD of their freedom, on which occasion the accused TT, against whom ongoing criminal proceedings are pending before the Court of Bosnia and Herzegovina for the same criminal offense, ordered the injured BB to come out of the shed, to go with them and to call the other men. When the injured BB came out of the shed, he was hit on the head with a rifle butt, pulled by the hair and his head was bashed against the door of the shed, and then he was pushed into the back seat of the Lada station wagon, during which time the **accused AA** and other persons stood by the mentioned vehicles, after which they went to the houses of the injured persons DD and VV, who jumped out of the window in fear of arrest. They were then ordered to come with them, which they did in fear, after which they were pushed into the back seat of the Lada station wagon, from where they were driven across the bridge to the right bank of the Rzav River to the Kolone settlement in the Višegrad municipality, where civilians DjDj and EE were also apprehended. The **accused AA** ordered them to go with them, while the accused PP and TT, against whom criminal proceedings are pending before the Court of Bosnia and Herzegovina for the same criminal offense, stood by the mentioned vehicles, ordering the injured parties DjDj and EE to come with them, which they did in fear, after which they were pushed into the mentioned vehicles and driven in the direction of Užice, from when all trace was lost of the injured parties BB, VV, DD, ĐĐ and EE, and today they are considered missing persons,

- by which he had committed the criminal act of war crime against the civilian population from Article 142 (1) under Article 22 of the CC of the FRY.
